5.2. Special hazards arising from the substance or mixture

HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

Do not breathe combustion products. SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS
