## SECTION 4. First aid measures

### 4.1. Description of first aid measures

## GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for particulate not otherwise classified (PNOC respirable fraction: 3 mg/m<sup>3</sup>; PNOC inhalable fraction: 10 mg/m<sup>3</sup>).
