5.2. Special hazards arising from the substance or mixture

SECTION 6. Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

If there are no contraindications, spray powder with water to prevent the formation of dust. SECTION 8. Exposure controls/personal protection
