## **SECTION 4. First aid measures**

## 4.1. Description of first aid measures

## 5.2. Special hazards arising from the substance or mixture

### HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

Do not breathe combustion products. ## 8.2. Exposure controls
