5.2. Special hazards arising from the substance or mixture

HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

Do not breathe combustion products. The product is combustible and, when the powder is released into the air in sufficient concentrations and in the presence of a source of ignition, it can create explosive mixtures with air. SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS

8.2. Exposure controls
