## **SECTION 4. First aid measures**

## 4.1. Description of first aid measures

In case of doubt or in the presence of symptoms contact a doctor and show him this document.

## 5.2. Special hazards arising from the substance or mixture

## HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

## **SECTION 8. Exposure controls/personal protection**

#### 8.1. Control parameters

During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for particulate not otherwise classified (PNOC respirable fraction: 3 mg/m3; PNOC inhalable fraction: 10 mg/m3). For values above these limits, use a P type filter, whose class (1, 2 or 3) must be chosen according to the outcome of risk assessment. #### 8.2. Exposure controls
