## MATERIAL SAFETY DATA SHEET

In accordance with Regulation (EC) No 1907/2006 (REACH)<sup>1</sup>, kit VC194065 – CLOSTRIDIUM DIFFICILE GDH do not require Material Safety Data Sheets on account of its classification as non-hazardous to health and the environment because it does not contain substances and/or mixtures which meet the hazard classification criteria available in Regulation (EC) No 1272/2008 (CLP)<sup>2</sup>, or which are in concentrations higher than the value established in the mentioned regulation for their declaration. The VC194065 kit manufactured by Mascia Brunelli S.p.A. contain Sodium azide (CAS No. 26628-22-8) as a preservative. Due to its concentration <0.1% the preparation is not classified as dangerous on the basis of health and/or environment effects.

The concentration is lower than the generic cut-off values listed in table 1.1 of Annex I to Regulation (EC) No 1272/2008 and the substance does not have a limit of Community exposure in the workplace, neither are classified as PBT/vPvB, neither are they on the candidate list.

- **Precautions for safe handling:** Good Laboratory Practices. Wear Protective clothing, use disposable gloves, goggles and mask. Do not eat, drink or smoke or apply cosmetic products in the working area. Once you finish the test wash your hands. Avoid contact and contamination
- Conditions for safe storage including any incompatibilities: The kit can be shipped and stored at 2-30°C in a dry place until expiration date stated in the label. All the kit components are for only one use and should remain in its primary packaging until use. Do not freeze.
- Specific end use(s): Use only the diluent provided for sample dilution and other components provided in the kit.
- **Ecological information:** The product should be discarded in a proper biohazard container after testing. These containers should be discarded in accordance with local or national laws or regulations. The product contains no components considered to be either persistent, bioaccumulative and toxic (PBT), or very persistent and very bioaccumulative (vPvB). This product doesn't contain components with environmental endocrine disrupting properties.
